

Dragonvest has again received the Top 50 GP award from the CLPA

Dragonvest Partners was awarded the “2008 the Top 50 GP ” by CLPA (China Limited Partners Association) last year, which was followed by Dragonvest Partners winning “2009 the Top 50 GP ”award from CLPA together with some other very well-known VC/PEs such as Lightspeed, Infinity, WI Harper, NEA, Matrix, DFJ, DT Capital, SAIF , etc.

The key criteria were used to judge GP’s capability of operating a fund and investment potentials from the viewpoint of LP , including GP’s case amount, IRR, fund size, track record, innovation ability, risk management ability, symbolizing event, credit record. CLPA selected 50 GPs from thousands of VC/PEs who make investment in China, and the grand awarding ceremony was reported by Sohu.com and other mainstream medias. Dragonvest Partners’ GP management ability is highly recognized by CLPA members.

CLPA is a non-governmental association which registered in Hong Kong. CLPA has more than 50 organizational members, which manage than 50 billion dollars. The successful investment cases by CLPA members include the famous venture capital and private equity funds such as CDH Venture, Hony Capital, New Horizon Capital, Hope, Sequoia Capital China, DT Capital, and China Science & Merchants Investment Fund. CLPA keeps close contact with more than 50 organizational LPs, hundreds of alternative investment funds in China and overseas and multiple international associations. CLPA applies to promote LP get mature and development in Chinese market, and provide service for increase LP’s investment level of fund.
